

STERN PINBALL - LIMITED 90 Day Warranty

Alliance Metaversal Studio LLC (“Alliance Digital Media”) warrants to the original purchaser of this product that the medium on which the software program(s) are recorded (the “Cartridge”) is free from defects in materials and workmanship for a period of 90 days from the date of purchase. If the original Cartridge is found to be defective within 90 days from the date of purchase, Alliance Digital Media agrees to replace the original cartridge free of charge upon receipt of the original Cartridge at its service center, postage paid, with proof of purchase.

This warranty is limited to the Cartridge containing the software program that was originally provided by Alliance Digital Media. This warranty shall not be applicable and shall be void if, in the judgment of Alliance Digital Media, the defect has arisen through abuse, mistreatment or neglect. This limited warranty is in lieu of all other warranties, whether oral or written, express or implied, including any warranty of merchantability or fitness for a particular purpose, and no other representation of any nature shall be binding on or obligate Alliance Digital Media. If any such warranties are incapable of exclusion, then such warranties applicable to this product, including implied warranties of merchantability and fitness for a particular purpose, are limited to the 90-day period described above. In no event will Alliance Digital Media be liable for any special, incidental, or consequential damages resulting from possession, use or malfunction of this Alliance Digital Media product, including damage to property, and to the extent permitted by law, damages for personal injury, even if Alliance Digital Media has been advised of the possibility of such damages. Some states do not allow limitation as to how long an implied warranty lasts and/or exclusions or limitation of incidental or consequential damages so the above limitations and/or exclusion of liability may not apply to you. Please return the product along with (a) a copy of the original sales receipt showing the date of purchase, (b) a brief description of the difficulty you are experiencing and (c) your name, address (please no PO boxes) and phone number to the below address. If the product was damaged through misuse or accident (example scratches or cracks) or if you do not have a dated sales receipt, this 90-day warranty is rendered void. In these cases, you may return the product for a replacement by including in addition to the items above a cashier’s check or money order for the amount of \$10 (US Dollars), made payable to Alliance Digital Media, to cover shipping and handling costs.

We strongly recommend that you send your products using a traceable delivery method. Alliance Digital Media is not responsible for products not in its possession.
